## Parent/Guardian Statement of Agreement

In making application for my child(ren) to attend Heartland Christian School I acknowledge that I will fully agree and will support the school in every area of its philosophy and policies, including academic, behavioral, spiritual, dress, moral, and disciplinary policies.

Upon acceptance of this application, I agree to:

- Accept the responsibility for my child(ren)s education by supervising homework, being an encourager and keeping in regular contact with teachers.
- Support the school through attendance and participation in various school activities.
- Support the school's programs through prayer, time and financial gifts.
- Support the school's fund-raising efforts NOTE: Heartland Christian School depends on financial gifts above and beyond tuition, and thus conducts several fundraising events each year.
- Attend Parent Orientation, regularly scheduled Parent/Teacher meetings, and other parent meetings as requested.
- Remit tuition payment by the fifth of the month. I further agree to pay a \$25.00 late fee assessed to my account for any payment received by the school later than the fifth of the month. If payment is past due for more than 30 calendar days, I will be asked to remove my child(ren) from school until payment is made.
- Pay all registration, tuition, book fees, lunch counter, athletic, and other miscellaneous fees incurred by my child(ren).
- Pay the full tuition for the entire period of attendance through the end of the calendar month upon withdrawal/removal of my child(ren) from Heartland Christian School. Student records may not be forwarded to another school until all financial obligations have been satisfied.
- Pay reasonable attorney fees in the event that legal action is required to collect tuition.
- Allow my child(ren) to participate in all school activities, including bus trips, sports activities, and school sponsored trips away from school premises.
- Support my child(ren)s teacher in the enforcement of classroom rules, consistent with Christian principles and discipline, as set forth in the Scriptures.
- Adhere to the Bible's commands to make every effort to live at peace and to resolve disputes with each other in private or within the Christian community in conformity with the Biblical injunctions of I Corinthians 6:1-8, Matthew 5:23-24 and Matthew 18:15-20. I further agree to hold the school and its agents harmless for any liability to my child(ren) or any guardian or parent thereof because of any claims on behalf of my child against the school or any agent thereof because of any injury or alleged injury to my child. Should legal action, for any reason, be taken against Heartland Christian School or any employee or agent thereof, on my child(ren)s behalf and the school or its agent not be found at fault, I agree to pay any attorney fees, court fees, damages or other costs that Heartland Christian School or its agent should incur to defend itself against such action.
- Notify Heartland Christian School in the event that my marital status and/or custody of my child(ren) changes and that it is my responsibility to submit a corrected Parent/Guardian Statement of Agreement containing updated signatures and copies of legal documentation to support those changes.
